## Terms and Conditions:-

- 1) The no. of candidates will be taken not exceeding as proposed above and approved by the competent authority w.r.t each department/course.
- 2) The training will be for a period of 6 months only.
- 3) Only those students who have completed their respective course (degree/diploma) or are in final year/semester of the programme are eligible for the training.
- 4) **Application duly filled with applicant's photograph & contact details must be submitted with the following enclosure:-**
  - (i) Mark sheet of class 10<sup>th</sup> (attested photo copy)
  - (ii) Mark sheet of class 12<sup>th</sup> (attested photo copy)
  - (iii) Mark sheet of semester – duly attested by the principal of the institute.
  - (iv) NOC/Forwarding letter duly signed by the Principal/Dean/Director of the institute with their contact details. The college of the candidates must approve from UGC/AICTE the undertaking of approval from UGC/AICTE must be mentioned in the NOC/Forwarding letter.
  - (v) Character certificate from the institution where studying.
  - (vi) A demand draft of Rs. 3000/- as onetime fee for a period of six months, drawn in the favour of commissioner, North DMC must be submitted by the candidate after the candidate selection.
- 5) The selection of scrutinized candidates will be done through interview by the selection board.
- 6) The certificate of the training will be issued by the concerned HOD of Department/Course after satisfactory completion of the said periods. In case of Dental and Dietics department the observer trainee may be allowed for 3 months also.
- 7) The candidate must submit the mark sheet of his final year/semester exam proving his completion of theoretical course programme before training completion certificate issued.
- 8) No T.A. / DA will be admissible to him/her for training.
- 9) **A notarized affidavit on Rs. 10/- non-judicial stamp paper must be submitted with the following points:-**
  - a) That I (the candidate) will not claim any stipend/salary for the training period.
  - b) That I will have to replace/pay if any damage is done by me to the belonging of the department during the training period.
  - c) That I follow all rules of the department/institute including leave rule & duty roster as applicable.
  - d) That I will submit a "No dues" clearance from the department before claiming for the training completion certificate.

- e) That the certificate for training shall be given only after completion of the said period of training/observership given by the concerned HOD.
- f) That an unusual absenteeism will lead to termination of my training at KH no fee will be refunded.
- g) That I shall not claim for any regular/adhoc appointment to the post after completion of training.
- h) That he/she shall file a Self declaration to the effect that the certificates/documents produced by him/her and the copies of the same deposited by him/her with the application form and during the course of verification of certificates/documents by the Board/Department are genuine and are issued by recognized institute/Board/University as the case may be and if the same are found to be fake/false, subsequently, his/her training shall be liable to be terminated without any notice, in addition to penal action as warranted by appropriate authority.
